Subject: Violations of international law by Israel

## Resolution 250210

Adopted by the World Embassy Desk on 10 February 2025,

*The secretary-General*

*Recalling* its primary responsibility under the Charter of the WED for the maintenance of international peace and security and compliance with international law,

*Gravely concerned* by the ongoing violations of international humanitarian and human rights law in the occupied Palestinian territories, including Gaza and the West Bank,

*Reaffirming* the applicability of the Fourth Geneva Convention relative to the Protection of Civilian Persons in Time of War to the Occupied Palestinian Territory, including East Jerusalem, and the occupied Syrian Golan,

*Noting* the advisory opinion of the International Court of Justice dated 19 July 2024, which concluded that Israel's continued presence in the Occupied Palestinian Territory is illegal and violates fundamental principles of international law,

*Noting* the contempt of the International Criminal Court and its arrest warrant issued by on 21 November 2024 of Mr Netanyahu, the Prime-Minister, and Mr Gallant, the Minister of Defense at the time, for their suspected involvement in War crimes and Crimes against humanity;

*Expressing grave concern* over Israel's recent military actions and prolonged occupation in both Palestinian and Syrian territories, which have led to significant civilian casualties and widespread destruction,

*Deeply alarmed* by the continued expansion of illegal settlements, forced displacement of Palestinian civilians, and the disproportionate use of military force against civilians,

*Condemning* the recent actions by the Israeli government and military that have resulted in widespread civilian casualties, destruction of vital infrastructure, and the worsening of the humanitarian crisis,

*Recognizing* the need for accountability and justice to foster lasting peace and prevent further violations,

*Recognizing* the equality of all States and their obligation to comply with international law;

*Noting* deep concern that Israeli's actions, specifically the lack of effort to avoid civilian casualties and the use of starvation as a method of warfare, represent a violation of its obligations under international law, and the failure and the negligence of Israel to comply with the demands of the majority of World's States to respect international law;

*Expressing* its commitment to continue to achieve lasting and durable peace and security between the involved parties,

Acts as follows:

### **Operative Clauses**

*1. Condemnation of Unlawful Occupation and Annexation:*

Strongly condemns Israel's continued occupation and de facto annexation of Palestinian territories, including East Jerusalem, and the occupied Syrian Golan, in violation of international law and relevant United Nations resolutions.

*2. Demand for Immediate Cessation of Military Activities:*

Demands that Israel immediately cease all military operations in the Occupied Palestinian Territory and the occupied Syrian Golan, which have resulted in extensive civilian casualties and destruction of property.

*3. Call for Withdrawal from Occupied Territories:*

Calls upon Israel to withdraw its military forces from all territories occupied since 1967, in compliance with United Nations Security Council Resolution 242 and subsequent resolutions.

*4. Condemnation of Settlement Activities:*

Condemns the establishment and expansion of Israeli settlements in the Occupied Palestinian Territory and the occupied Syrian Golan, which constitute a flagrant violation of international law and a major obstacle to peace.

*5. Demand for Respect of International Humanitarian Law:*

Demands that Israel adhere strictly to its obligations under international humanitarian law, particularly the Fourth Geneva Convention, and cease all practices that violate the rights of the Palestinian and Syrian populations under occupation.

*6. Appeal to the International Community:*

Urges all States and international organizations to take all necessary measures to ensure Israel's compliance with international law, including the consideration of measures and other enforcement mechanisms to compel adherence.

*7. Support for the Right to Self-Determination:*

Reaffirms the inalienable right of the Palestinian and Syrian peoples to self-determination and independence, and supports all efforts to achieve a just and lasting peace in the region.

*Conclusion:*

This resolution serves as a firm denunciation of Israel's ongoing violations of international law in the Occupied Palestinian Territory and the occupied Syrian Golan.

It underscores the urgent need for Israel to comply with its legal obligations, cease all unlawful activities, and engage in genuine efforts to achieve a just and lasting peace in the Middle East. It urges the states to join and to enforce international law and to protect civilian casualties.

*Appeal*

1. *Affirms* that the State of Israel, the State of Palestine and the Syrian Arab Republic have the right to appeal this resolution under Chapter IV of the Charter of the WED within 30 days;
  2. *Affirms* that Member States could substantiate a request for a reconsideration of the resolution or the use of Tools within 15 days;
